ROBYG S.A. – Signing of the agreement on the purchase of the land by a company from the capital group of ROBYG S.A.

Contents of the Current Report:

The Management Board of ROBYG S.A. with its seat in Warsaw (the “**Company**”) hereby announces that on 9 February 2016 a subsidiary of the Company has entered into the purchase agreement on the purchase of the ownership right to the land composed of the plot of land located in Gdańsk with the area of app. 0.7088 hectares for the total purchase price of PLN 5,500,000.00.

The value of the above-mentioned transaction does not exceed 10% of the Company’s equity.
