The Management Board of ROBYG S.A. with its registered office in Warsaw (the “**Company**”), in performance of its obligation under Article 70 Point 1) of the Act of 29 July 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies (the “**Public Offering Act**”), hereby informs that on 19 August 2026 the Company received from TAG Immobilien AG and TAG Beteiligungs- und Immobilienverwaltungs GmbH a notification submitted pursuant to Article 69.2.2. of the Public Offering Act on the change in the total number of shares and the total number of votes at the Company’s General Meeting of Shareholders in connection with the registration by the competent court of an increase in the Company’s share capital through the issuance of series C shares of which the Company informed through the current report No. 27/2026 dated 18 August 2026.
