The Management Board of ROBYG S.A. with its registered office in Warsaw (the "**Company**"), hereby informs that on 17 July 2026 it received from Erste Group Bank AG (the "**Stabilising Manager**"), pursuant to the stabilisation agreement executed on 16 June 2026 and on the terms disclosed in the Company's prospectus approved by the Polish Financial Supervision Authority and published on 16 June 2026, information on stabilisation measures undertaken by the Stabilising Manager in respect to the shares in the Company listed on the regulated market operated by the Warsaw Stock Exchange in the period from 10 to 17 July 2026, pursuant to which the Stabilising Manager acquired in total 24,916 ordinary bearer shares in the Company listed on the regulated market.

The detailed information on the stabilisation measures executed on specific dates are presented in the schedule to this current report.
